In such cases Commission Regulation (EC) No. 800/2008 may be applied, by which certain categories of support are declared to be compatible with Common Market in accordance with Articles 87 and 88 of EC Treaty (general regulation regarding block exemptions), and in accordance with support categories stated in Chapter II of Section 8 Educational Support, or Section 5 Advisory Services Support on behalf of small and medium-sized enterprises and their participation in trade fairs. In relevant cases the provisions of Commission Regulation (EC) No. 1998/2006 may be followed, regarding the application of Article 87 and 88 of the Act for the de minimis support, or the mode of support will be notified.
