# 1. Reporting on the programme implementation



## Programme Recap of 2014

- The **Call for proposals** 2013 launched on 29 November 2013 and closed on 3 February 2014
- **Evaluation** between February and June 2014 – included formal check and evaluation of proposals by international independent experts
- Programme Committee (PC) meeting on 11-12 June 2014 - the **best projects** recommended and selected for the financial support – 19 in total
- Recommendation by the PC was fully endorsed and approved by the Programme Operator
- **On 15 July 2014 - results of the Call** announced by Programme Operator
- On 12 September 2014 - the Programme Operator issued **project contracts**  
The projects realization started at the latest on 12 November 2014
- On 27 October 2014 the Programme Operator sent **first payments** to the project promoters amounting to 82,740,000 CZK including projects support (regranting) and project preparatory costs (Fund for bilateral relations).

# 1. Reporting on the programme implementation



## Programme Recap of 2014

- **prolongation** of eligibility of Programme expenditures originally set to 30 April 2017 was extended **till 31 December 2017**
- **But project expenditure eligibility by 30 April 2017!**
- amendment of Annex I. to the Programme agreement was issued and accepted on 29 October 2014
- Additionally, it was decided about a **reallocation of 2,016,377 €** i.e. 53,433,991 CZK (exchange rate 26.5 CZK/€) from the programme **Carbon Capture and Storage CZ08** in the following areas: *Pilot Studies and Surveys on CCS Technology*. Approved by Norwegian Ministry of Foreign Affairs.
- **reallocation requires 25 million CZK** as co-financing which is the Programme Operator ready to provide.
- to use all reallocated funds together with MEYS contribution for institutional support of selected research projects from the reserve list.

# 1. Reporting on the programme implementation

## Programme Recap of 2014

- submitted 389 in total of applications for projects
- 6 applications were found ineligible

Total amount applied for is 7,827,671,000 CZK (€ 295,384,000 €)

**Amount available 433,548,000 CZK** (16,360,301€ e.g. 13,088,241€ Programme + 3,272,060€ national-co-financing).

All available allocation was fully spent.

The Programme Committee fully endorsed the ranking order.

- 19 proposals were selected for funding (1 quit later in December 2014)

**7 proposals were put on the reserve list.** Up to 4 of them are likely to be funded in case funds are transferred from programme CZ08.

Out of the 19 proposals selected (now 23 supported projects):

At least 23 have Norwegian partner/partners

1 has apart from a Norwegian partner a partner from Switzerland (but not supported from the programme).

# 1. Reporting on the programme implementation



## Reporting on outputs

The single outcome of the Programme is *Increased research cooperation between Norway and the Czech Republic*. This outcome is broken down into 3 main outputs:

**(1) *International research cooperation projects*** expressed in number

– target: 40 projects - 23 projects are supported.

**(2) *Suitable conditions and environment for young researchers***

(Number of female researchers and PhD and Post docs students involved in cooperating projects) – target: 20 female researchers and 20 PhD or post docs students - shall be achieved.

**(3) *Number of Internationally refereed scientific publications***

– target: 40 - cannot be estimated in this early stage of implementation.

The targeted number of cooperating research institutions by country is 50. The actual number is 59 teams from 40 research organisations.

# 1. Reporting on the programme implementation



## Monitoring of Programme

In 2014 the Programme underwent 2 audits provided by Audit Authority and Programme Operator.

Both audits **confirmed proper and correct settings** of management and control systems at CZ09.

On 5 September 2014 PO received the report called *Opinion verifying compliance of the management and control systems* by Audit Authority NFP prepared for FMO confirming the setting of the management and control systems at PO.

February – June 2015 – audited by Moore Stephenson contracted by FMO in Brussels.

2nd audit of Audit Authority has been launched in September.

# Programme Budget

- Budget has been increased by 2,016,377 Euro due to reallocation from CZ08 programme.
- All support was allocated to Regranting+Bifond+Complementary Actions.
- No increase in the item *Management costs*.

# CZ09 Programme budget spending

- **All projects CZ09 meet the formal requirements in periodic reporting for 2014!**
- Institutional support for 2015 is being distributed to project promoters (11 out of 18 projects have received support for 2015)
- First payments to four projects from reserve list (additional allocation) have been executed in September 2015! 😊


