10.00 – 10.30 **ZAHÁJENÍ KONFERENCE**

10.30 - 11.00 **How we are doing the Audit (Erik Arnold).** Presentation of the overall work programme, with short inputs from work packages not presented at the conference.

11.00 – 12.30 **Governance and Management of the Czech R&D&I system in international comparison (Erik Arnold and Bea Mahieu).** The presentation will discuss reforms, governance structures and processes used in the Czech R&D&I system in comparison with international practice. It will also discuss how R&D&I programme design, management and implementation compares with practices in other countries.

12.30 – 13.30 **OBĚD**

13.30 – 14.30 **R&D inputs and outputs in the Czech Republic (Thed van Leeuwen).** The presentation will sketch an outline of the way research is funded in the Czech Republic and then go through a more detailed discussion the research community's bibliometric performance, compared with world performance overall and with the performance of a number of benchmark countries.

14.30 – 15.00 **The research Evaluation Guidelines in international perspective (Fritz Ohler, Brigitte Tiefenthal).** The presentation explains the evolution and current character of the Evaluation Guidelines currently used to allocate institutional funding in the Czech Republic today. It reports on the views of people in the research community about the Guidelines and the way they are being used. It compares Czech practice in this respect with the systems used on some other countries.

15.00 – 15.30 **What research assessment means for a leading university: How Manchester University tackles the Research Assessment Exercise (Luke Georghiou).** The UK has long experience of operating a Research Assessment Exercise, which is intended both to (re)allocate institutional research resources among the universities but also to provide an element of formative evaluation, helping departments to improve. Manchester University has invested considerable effort in understanding the needs and effects of the RAE. The presentation will discuss these effects and the ways that Manchester prepares for and manages its RAE participation so as to maximise the benefits it obtains.
