## What is the TOEFL iBT Test?

- The world's premier English-language proficiency test for university study, work and immigration
- An academic English test that uses integrated questions to measure all four language skills:

If your institution is authorized to receive GRE and/or TOEFL scores, you will have an official ETS **Designated Institution (DI) or Attending Institution (AI)** score delivery code and can request access to use the ETS Data Manager and assign Lead Administrator or Secondary Score User.

## **Roles in ETS Data Manager**

**Lead Administrators** are institutional representatives who are responsible for approving and managing access to online score data at their institution. They can:

- Access score data for their institution.
- Approve access to score data and other services for secondary users at their institution.
- Create new users directly in the portal for immediate access to score data.
- Share a link with their staff or faculty to complete a Request Form to access score data online.
- Modify user's profiles and are deactivate user's access when staff leave the institution or change positions.

**Secondary Users** are institutional representatives who need to access score data online but aren't responsible for approving and managing who has access to score data for their institution.

Secondary Users can access score data and other services that their Lead Administrator approves for them.

Institutions can also request to receive individual test taker score data via server-to-server feed.

This service provides the ability to download test taker score from ETS server to client server. This can be done on demand or via a scheduled job. Requires one-time set-up by institution's IT or technology staff with understanding of programming language such as Java, Perl, PHP or .NET. ( <u>How to request server-to-server feed</u>)

## What happens after I request an access?

When your access is approved, you will receive three emails from <u>noreply@ets.org</u>:

- an email indicating which testing programs and services you have been approved for
- an email containing your assigned username with a link to the ETS Institution Portal sign-in page
- an email containing a temporary password with a link to the ETS Institution Portal sign-in page

The first time you sign in with your username and temporary password, you will be prompted to enter your temporary password, then create and confirm a new password. In addition, you must select a security question and provide an answer to verify your identity if you forget your password in the future.

If you did not receive these emails, check your Junk Email or Spam folder. Also be sure to add "@ets.org" to your address book or safe sender list to make sure you receive important confirmation emails from ETS.



How fast do scores appear in the ETS Data Manager? Score reporting runs occur twice a week for GRE and daily for TOEFL, scores appear within 24hrs of each score run When will I receive confirmation? After requesting access, in case approved, you will receive a confirmation in 7-10 business days

For both GRE and TOEFL, an institution can only see the scores that test taker designated them to see. If they did not do so, test taker needs to order an additional score report to be sent to your institution.

## Test Security – TOEFL iBT® Test Center

ETS has long been at the forefront of combatting test security concerns:

- **Test-day security procedures** include biometric voice identification, facial recognition and the use of electronic wanding at test centers.
- All human rating is done anonymously, eliminating opportunities for fraud between test takers and interviewers.
- Scoring isn't done at test centers and records aren't stored there.
- **Student identity is confirmed** comparing valid government issued national/federal/provincial ID containing test taker's signature and photographs with test taker photo captured on test day.

TOEFL iBT Home Edition employs multiple best-in-class security measures that use both real-time human monitoring and artificial intelligence technology:

- **100% Live human proctoring -** ensures constant vigilance, including confirming the test taker's identity and scanning their home environment before testing begins, flagging any suspicious activity and intervening if necessary.
- Artificial Intelligence technology such as facial recognition, gaze tracking and video recording of the entire session will guard against malicious activity.
