FORUM CONCEPT

Democracy is in crisis throughout the world, with political developments threatening the principles of democracy, human rights, and the rule of law. Higher education, science, and the pursuit of knowledge are similarly faced with significant challenges at this time. More than ever, colleges and universities have a crucial role to play in the development and preservation of democratic societies. This moment calls for higher education to actively embrace its civic and democratic purposes, as well as stand for and exemplify democratic values including diversity, inclusivity, tolerance, equity, and open inquiry.

The "Global Forum on Higher Education 2025: Renewal of the Democratic and Civic Mission"—hosted by Charles University in Prague in partnership with The Ministry of Education, Youth and Sports of the Czech Republic—marks the eighth installment of a collaborative effort between the Council of Europe and the International Consortium for Higher Education, Civic Responsibility, and Democracy. This invitational meeting also marks the second gathering hosted by a larger cooperation—the Global Cooperation for the Democratic Mission of Higher Education—which includes the Council, the International Consortium, the Organization of American States (OAS) and the International Association of Universities (IAU).

The overall focus of the 2025 Global Forum on Higher Education is on the threats to democracy—which includes attacks on higher education's democratic and civic work and mission—and higher education's role in combatting those threats.

The attacks on academic freedom, higher education as a public good, human rights, and democracy itself have accelerated at an alarming rate.

It is more important than ever that the global higher education community—including institutional leaders, faculty, students, public authorities/ government partners, and civil society—come together.

GUIDING QUESTIONS & FRAMEWORK

The 2025 Global Forum's particular focus is on bringing voices from diverse regions around the world together for sharing information, understanding, and collaborative solutions to what *specifically* can be done to renew higher education's civic and democratic mission in order to preserve, strengthen, and advance democracy during this time of growing autocracy and authoritarianism.

The Forum's overall discussion is being framed around these four questions:

- What is the nature of the current threats to democracy and higher education's democratic work?
- What are the causes (including higher education's failure to sufficiently stand for its democratic mission)?
- What AND how can higher education do to change the current situation and effectively combat the threats to democracy?
- What AND how can the Global Cooperation for the Democratic Mission of Higher Education and its constituent partners (the Council of Europe; IAU; International Consortium; OAS) do to effectively combat the threats to democracy and help renew higher education's democratic mission?

We anticipate responses to these questions will have both regional utility and global resonance. The General Rapporteur's Report coming out of the conference will help capture the key themes and recommended best practices and policies, as well as possible steps forward and future action, including ongoing dialogue, webinars, and meetings.

A set of principles will also be produced as one of the outcomes of the Forum to help guide our future collective work as well as the work of the many partners participating in the Global Forum to effectively renew higher education's commitment to strengthening democracy on campus, in the wider society, and indeed throughout the world.

ABOUT THE GLOBAL COOPERATION

The Global Cooperation for the Democratic Mission of Higher Education works to build a global movement to fulfill higher education's democratic mission and strengthen the role of higher education in developing, maintaining, and sustaining democracy on campus, in the community, and the wider society. The cooperation is comprised of four pillar organizations: the Council of Europe; the International Association of Universities; the International Consortium for Higher Education, Civic Responsibility, and Democracy; and the Organization of American States.

The Council of Europe (CoE) and the International Consortium for Higher Education, Civic Responsibility and Democracy (IC) have worked in cooperation since 1999 to advance the contributions of higher education to the development of democratic culture. The Organization of American States (OAS) joined this cooperation in April 2018 and the International Association of Universities (IAU) in October 2019. In January 2021, the CoE, the IC, the OAS, and the IAU named their partnership the Global Cooperation for the Democratic Mission of Higher Education.

The Global Cooperation has undertaken cross-national research projects and joint meetings to share best practices, as part of its efforts to advance the contributions of higher education to the development of democratic societies. The first cross-national research project between the CoE and IC started in 1999, with the research findings published by the CoE in *The University as Res Publica: Higher Education Governance, Student Participation and the University as a Site of Citizenship* (2004). Seven global forums have been hosted:

- Higher Education and Democratic Culture: Citizenship, Human Rights, and Civic Responsibility (2006, Council of Europe, Strasbourg)
- Higher Education for Modern Societies: Competences and Values (2008, Council of Europe, Strasbourg)
- Reimagining Democratic Societies: A New Era of Personal and Social Responsibility (2011, University of Oslo)
- Higher Education for Democratic Innovation (2014, Queen's University, Belfast)
- Higher Education for Diversity, Social Inclusion, and Community: A Democratic Imperative (2017, LUMSA University, Rome)
- Academic Freedom, Institutional Autonomy and the Future of Democracy (2019, Council of Europe, Strasbourg)
- Higher Education Leadership for Democracy, Sustainability and Social Justice (2023, Dublin City University)

The Forums have resulted in publications on each conference theme. Three other books have been published that were stimulated and edited by partners involved in the Global Cooperation: *The Local Mission of Higher Education: Principles and Practice* (2019); *Higher Education's Response to the COVID-19 Pandemic: Building a More Sustainable and Democratic Future* (2021); and *Higher Education in Latin America and the Caribbean: Civic Engagement and the Democratic Mission* (2023).

At the 2006 Global Forum, a declaration on "The Responsibility of Higher Education for a Democratic Culture: Citizenship, Human Rights and Sustainability," was adopted by acclamation, affirming the need to increase the commitment of higher education institutions to democratic culture and sustainable societies. It also called for action to promote the principles of democratic citizenship, human rights, and civic responsibility. At the 2019 Global Forum, participants adopted a declaration supporting the role of academic freedom and institutional autonomy in ensuring the future of democracy, which was widely distributed. The 2025 "Global Forum on Higher Education 2025: Renewal of the Democratic and Civic Mission"—hosted in partnership with Charles University and The Ministry of Education, Youth and Sports of the Czech Republic on 3-4 June 2025—marks the eighth installment of this collaborative effort.

Global Cooperation for the Democratic Mission of Higher Education









The Council of Europe (CoE), established in 1949, promotes human rights, democracy and the rule of law, develops continent-wide agreements to standardise member countries' social and legal practices, and promotes awareness of a European identity across cultures based on shared values. It comprises 46 member countries. The Steering Committee for Education oversees the Council of Europe's programmes in the field of education and advises the Committee of Ministers on education issues. Governments of the Council of Europe member States are represented in the Committee by senior officials from the general education and higher education sectors.

The International Association of Universities (IAU), created under the auspices of UNESCO in 1950, represents universities and other higher education institutions, organisations and affiliates across 130 countries. The IAU acts as the global voice of higher education and its organisations, in particular to UNESCO, advocating and advancing a dynamic leadership role for higher education in society. Articulating the fundamental values and principles that underpin education and the pursuit, dissemination and application of knowledge, the Association advocates the development of higher education policies and practices that respect diverse perspectives. In addition, it promotes social responsibility and contributes to the development of a sustainable future.

The International Consortium for Higher Education, Civic Responsibility and Democracy (IC) was created in 1999 to work with the Council of Europe with the objective of developing, explaining, and advancing the contributions of higher education to democracy on college and university campuses, their local communities, and the wider society. It is composed of the United States (represented by a Steering Committee from the American Association of Colleges and Universities, American Association of State Colleges and Universities, American Council on Education, Anchors Institutions Task Force, Campus Compact, and NASPA-Student Affairs Professionals in Higher Education); Australia (represented by Engagement Australia); the United Kingdom (represented by the National Co-ordinating Centre for Public Engagement); Ireland (represented by Campus Engage); South Africa (represented by Universities South Africa); and the Magna Charta Observatory.

The Organization of American States (OAS), established in 1948, is the main political forum of the Western Hemisphere. It gathers all 35 independent states of the Americas to jointly promote and consolidate democracy; strengthen human rights; foster peace, security, and cooperation; and advance in achieving common interests. Since its inception, the main objective of the OAS has been to prevent conflicts and support political stability, social inclusion, and prosperity in the region through dialogue and collective actions including cooperation and mediation.
